Introduction to classification units

Description This classification unit covers firms that install, service or repair roofs with a slope generally greater than 4 in 12 (33%). Firms that power wash or restore steep sloped roofs are also included here.

Hazard rating assignment Based on the nature and extent of the risks and hazards in this classification unit, firms in this classification unit are assigned a high hazard rating for the purpose of defining first aid-related requirements (i.e., the application of G3.16, First aid assessment, in the Occupational Health and Safety Regulation). This section of the Regulation specifies mandatory minimum levels of first aid, including what type of first aid kits, facilities, and equipment are required.

When to contact us Firms in this classification unit may also occasionally engage in other business activities. However, if they have a significant presence in any of the following industries, it may make sense for them to be assigned to another classification unit.

- 1) installation, service or repair of asphalt roofs, low slope roofs, gravel roofs, or torch on roofs (see CU 721036); or
- 2) cleaning, power washing or restoration of roofs which does not require the worker to walk on the roof (see CU 764022).
